# 2024 MONTCALM COUNTY FAIR GENERAL RULES and REGULATIONS

All exhibitors and club leaders must read and carefully follow all rules and regulations listed in the current fair book.

All fair registration forms are available online at www.montcalmcountyfairgrounds.com.

## **FAIRGROUNDS**

- 1. The Montcalm County Fair Association and/or Fairboard will not be responsible for any injury, loss, or damage, whatever the reason, incurred while camping/visiting on the fairgrounds, including responsibility for personal accidents or loss, or injury to an exhibit, although precautions will be taken to ensure the safety of exhibits.
- Unauthorized animals and/or pets are not allowed on the fairgrounds at any time, with the exception of dogs. Dogs are allowed in the camping area ONLY and MUST BE LEASHED/TIED or CAGED AT ALL TIMES. Exhibiting dogs are allowed in their assigned areas during show times.
- 3. Exhibition and other authorized animals must be properly caged, penned, stalled, or under the direct control of their handler and remain in the assigned areas for their species.
- 4. **An 11:00 p.m. curfew** on the fairgrounds will be enforced unless accompanied by a parent or leader.
- 5. Quiet hours, 11:00 p.m. to 6:00 a.m., are to be observed.
- 6. NO ALCOHOLIC BEVERAGE OR ILLEGAL SUBSTANCES ARE PERMITTED ON THE FAIRGROUNDS, including in the entire camping area and parking areas.
- 7. Any exhibitor or person showing disrespectful and/or unsportsmanlike behavior, as deemed by the Montcalm County Fair Association Fairboard, may be asked to remove themselves, or be removed, from the area, or from the fairgrounds and/or not return and forfeit all premiums and awards.
- 8. Golf Carts or utility vehicles must register with the fair office. Proof of insurance and a \$40 registration fee will be required to be licensed for use during fair week. These vehicles are to be operated ONLY by licensed drivers and only on roads or parking areas of fairgrounds.
- 9. BICYCLES are NOT allowed on the fairgrounds.
- 10. Overnight camping and tents are permitted in designated camping areas ONLY and must follow campground rules issued with their camping assignment.
- 11. No roaming solicitors allowed on the fairgrounds.

## **YOUTH EXHIBITS**

- 1. Any project, animal or still exhibit that might jeopardize the safety of the exhibitor, other exhibitors, or the public will be dismissed from the grounds.
- 2. The Superintendent, and 4-H Program Coordinator, and a member of the Montcalm County Fair Association Fairboard, will handle controversies or conflicts. It is the intent of the Montcalm County Fair Association Fairboard to deal promptly and decisively on all issues at the time of the incident. A complaint/appeals process is listed.
- 3. Classes are open to all youth ages 8 19 as of January 1st of the current year that are enrolled in 4-H by April 1 of the fair year.
- 4. Youth Ages 5 7, as of January 1st of the current year, may participate in Cloverbud Classes, which are NOT eligible for competitive placing. These youth must be enrolled in 4-H by April 1 of the fair year to be eligible to show.
- 5. Entry forms will be available on the fair website.
- 6. Exhibitors may enter only one (1) exhibit in each class, unless otherwise stated. Check department rules for exceptions or restrictions.

- 7. All projects must be exhibited in the owner's name and shown by the owner, with the exception being that of a properly leased animal. Ownership is required for all market animals. Exhibitors of Market Rabbits must have the sire or dam in their possession by April 1st of the current year.
- 8. Project animals or still exhibits may NOT be shown in a youth class at any other County Fair during the current calendar year.
- 9. Each exhibitor, except cloverbuds (ages 5-7), is required to perform two or more clean-up hours at the fairgrounds, *prior to fair*, to be permitted to exhibit at fair.
- 10. Recommended dress for showing livestock is white shirt, dark pants (black dress pants), and leather shoes/boots unless specifically listed in project area. It is the responsibility of the exhibitor to learn the expectations of standard dress, if applicable, or safety requirements.
- 11. No animal may be shown in showmanship by more than one (1) exhibitor per year, (the animal must be registered to the exhibitor showing it) except Cloverbuds, when required under Cloverbud rules.
- 12. Still projects (non-animal) must be the original work of the exhibitor and completed by the owner since last year's fair.
- 13. Resource information for youth projects can be located in the 4-H Bulletins and all exhibitors are expected to be able to tell the judge about their project and what they have learned.
- 14. All exhibitors will be assigned a number upon receipt of entries.
- 15. By June 1st Administrative Club Leaders need to provide by June 1st an estimated need for exhibit space to the Still Exhibit Superintendent, and an estimated number of animal pens and stalls to the Montcalm County Fair Association Agriculture Committee (MCFAAC).
- 16. Placing is at the discretion of the judge. Judge's decisions are FINAL.
- 17. The judge will select projects for additional honors in each division. From this honor group, outstanding ribbons may be awarded. Best in Show may be selected from the outstanding projects.
- 18. Early release of animals or exhibits, prior to the stated dismissal time, must have written pre-approval by the Department Superintendent, MSU Montcalm Extension office and Montcalm County Fair Association Fairboard by June 1st. Failure to comply will result in forfeiture of all ribbons and awards and a one year probation from showing that species at the Montcalm County Fair.
- 19. Exhibits will be released as of 6:00 a.m. the Sunday ending fair. All exhibits must be picked up by 11 a.m.

## MONTCALM COUNTY FAIR CODE OF CONDUCT and DRESS CODE

Exhibitors, leaders, and spectators are asked to abide by the following guidelines while at the Fair. We are proud of your individuality and sense of style but wish to remind you that you represent the public image of the Fair and 4-H in Montcalm County.

- 1. Profanity and vulgar suggestions (including displayed on clothing) are NOT permitted and may result in removal of an exhibitor, leader or parent from the area or grounds.
- 2. Clothing promoting or advertising alcohol or illegal drugs, or dealing with death, destruction or suicide will NOT be permitted.
- 3. Exposed undergarments are NOT permitted. Pants or shorts must be appropriately fitting and be worn around the waist (no sagging or exposure).
- 4. Conspicuously thin garments, bare midriffs, swimsuits, or halter tops are NOT permitted in exhibiting areas.
- 5. Professionally tailored sleeveless clothing will be appropriate in the show ring or sale ring.
- 6. Appropriate leather footwear is required. No open toe style such as sandals, flip-flops, etc. Tennis shoes are appropriate in some areas.
- 7. Appropriate dress is required in the auction ring. Showmanship clothing is allowed, as well as 4-H/FFA theme or logo t-shirts or polo shirts. Appropriate pants and footwear must be worn.
- 8. Cell phones are NOT permitted in the show ring or sale ring.
- 9. ALL parents, club leaders and superintendents are asked to support and encourage proper conduct.

# **COMPLAINT/APPEALS PROCESS**

Exhibitors may not file a complaint or appeal on judging results. All judging results are final.

# An exhibitor may file a complaint regarding any of the following:

- 1. Conflict of interest of the judge.
- 2. Disqualification of an exhibit or exhibitor.
- 3. Exhibitor, group leader or superintendent behavior.
- 4. Eligibility of exhibit.

# The procedure for filing such a complaint/appeal shall be:

- 1. Exhibitors are allowed to file a written complaint within 10 days after the end of the fair.
- 2. Any exhibitor who wishes to file a complaint/appeal shall obtain a complaint/appeal form from the Fairboard.
- 3. The form must be returned to the Fairboard office or mailed to "MONTCALM COUNTY FAIR ASSOCIATION, P.O. BOX 513, GREENVILLE MI 48838".
- 4. The Fairboard will notify the exhibitor in writing upon receipt of the complaint/appeal form.
- 5. The complaint/appeals committee shall consist of the Montcalm County Fair Association Executive Committee.
- 6. The committee shall meet within 15 days of receipt.
- 7. The committee shall investigate on a per case basis by contacting all parties involved to ask questions and clarify details, as well as reviewing the rules and pertinent documentation.
- 8. The committee shall meet within 15 days of the review meeting to discuss information obtained through the investigation process and will make a final decision regarding the complaint/appeal. The exhibitor will be notified in writing of the committee's decision within 5 days of this meeting.
- 9. The exhibitor may make an appeal to the Michigan Department of Agriculture and Rural Development within 45 day of filing the initial complaint/appeal, if the exhibitor is not satisfied with the Montcalm County Fair Association's action. The Michigan Department of Agriculture and Rural Development shall have 60 days after receipt of any appropriately filed complaint/appeal to investigate the complaint/appeal and shall issue a finding of fact and notice of department action and recommended actions for the Montcalm County Fair Association.

# LIVESTOCK YOUTH CLASS RULES GENERAL RULES FOR LIVESTOCK

- All animals (including market animals) MUST BE in the exhibitor's possession and registered with the MONTCALM COUNTY FAIR ASSOCIATION office by the required date for each species. Large animal registration forms must be turned in, in person, at a Livestock committee (MCFAAC) meeting, or weighin/tag-in. Small animal registration forms must be turned in, in person, at a Livestock committee (MCFAAC) meeting, or a small animal committee meeting. Forms must be turned in, in person, and will not be accepted via email or mail.
- 2. Animal Registration Forms are available online from the Montcalm County Fair Website: www.montcalmcountyfairgrounds.com.

3. Showmanship and completed record books, will be required for every animal species in which an exhibitor shows an animal.

## **HEALTH REGULATIONS**

- 1. Livestock exhibitors MUST be in compliance with the Michigan Department of Agriculture and Rural Development (MDARD) Animal Health Requirements as defined. Rules can be located at: www.michigan.gov/mdafairreqs.
- 2. All animals MUST be clean or bathed before arrival at the fair, or will not be allowed to unload, as this improves measures in preventing communicable disease.
- 3. All animal clippings/shearing MUST be done prior to fair arrival, except for touch-up clipping prior to show. Animals with active warts, pink eye or active ringworm will NOT be allowed on the fairgrounds.
- 4. All animals MUST be free from infectious, contagious diseases and/or parasites.
- 5. All animals suspected of being on tranquilizers, other drugs or antibiotics fed beyond the withdrawal period will be subject to testing.
- 6. All steers MUST be dehorned, without regrowth of more than 1", and healed prior to fair. No scurs longer than 1" (except: Scottish Highlanders).
- 7. All Beef, Dairy and Swine MUST comply with MDARD RFID Tag Regulations. See the MDARD Requirements.
- 8. All Goats and Sheep MUST comply with the Scrapies Identification Tag/Tattoo Regulations. See the MDARD Requirements.

## **EXHIBITORS RESPONSIBILITY FOR CARE OF PROJECT ANIMALS**

By registering an animal to bring to the Montcalm County Fair, each exhibitor is agreeing to the following project animal certification:

- 1. We certify that we will not have administered to the animal(s), nor has it received, any substance not approved by the Federal Food and Drug Administration (FDA), the United States Department of Agriculture (USDA) and/or the County the exhibition is being held. This includes, but is not limited to, diuretics, steroids, repartitioning agents, tranquilizers, and analgesics. We also certify that, with respect to any drug, chemical or feed additive approved by the FDA and/or USDA for slaughter animals that no illegal use of approved chemical/compounds has taken place and that the applicable withdrawal period as recognized by the FDA has expired prior to shipping out of market livestock on any and all approved chemicals/compounds administered.
- 2. We acknowledge and accept the fact that all animals entered at the County Fair may be subject to blood, urine and tissue tests, and that the Fair reserves the right to disqualify any animals, either live or slaughtered, found in violation of the use of drugs, chemicals or feed additives as described above and, in the County, Fair Book and policy brochure. Disqualification will result in the placing(s) of the animal in question being voided; the forfeiture of any and all ribbons/trophies/special awards earned with the animal(s); the assessment of a fine against the total premiums due equal in the amount to the premiums earned with the animal(s); voiding of the sale(s) if the animal(s) has been sold in the Livestock Sale.
- 3. We will allow the designated tester/veterinarian to draw any and all samples deemed appropriate from our animal(s).
- 4. We will indemnify and hold harmless the Fair and all of its sponsors and assisting organizations and their employees and agents, against all legal or other proceedings in connection with said testing procedures. We will indemnify and hold harmless the Fair and its sponsors and assisting organizations against all claims of injury to the animal and any damage or injury to any person or property caused by the animal.

## **PROJECT ANIMAL CARE:**

- 1. We, the above signed exhibitor and parent/legal guardian, have read, acknowledge, accept and will abide by all the animal care, housing and maintenance rules as set forth in the County Fair Book, the appropriate species rule books.
- 2. We acknowledge that the above-mentioned animal(s) have been under my daily care since the initial tagging or project registration date.
- 3. Proper care (feeding, handling, etc.) of project animals and maintenance (cleanliness, neatness, etc.) of assigned fair housing is the responsibility of the exhibitor. Project animals must be cared for in accordance with commonly accepted feeding/handling practices, and the animal's pen/stall cleaned and bedded as necessary on a daily basis. Proper care and maintenance of all animals and their assigned housing area will be monitored by the appropriate species Superintendent of the Fair.

# **EXHIBITOR CODE OF CONDUCT:**

1. We agree to conduct ourselves with honesty, integrity, and good sportsmanship. We will treat all fair and livestock show management personnel, fair officials, judges, and exhibitors with courtesy, cooperation and respect and shall not direct any abusive or threatening conduct toward them. Furthermore, we will not direct criticism or interference with fair and livestock show management personnel, fair officials, judges, and exhibitors in conducting the activities associated with the event. We understand that any conduct that is contrary to these items will be brought before the Fair Board for review and may result in the disqualification of individual people and animal(s) from the activities associated with the County Fair.

## ETHICAL AND HUMANE TREATMENT OF ANIMALS:

- 1. We acknowledge that inhumane fitting, showing and/ or handling practices or devices shall not be used. Furthermore, surgery, injection, or application of foreign material under and/or into the flesh of an animal to physiologically or physically change the natural contour or conformation of the animal is illegal. The use of showing and/or handling practices or devices such as striking animals to cause swelling, using electrical contrivance, insertion of foreign material in the animal, or other such practices are not acceptable and will be prohibited. Violation of the above-mentioned items could result in the disqualification of the animal and/or exhibitor.
- 2. We acknowledge and accept the fact that the Superintendent for a given animal species and the County Fairboard Livestock personnel may authorize the examination of a given animal for identification purposes and/or health related concerns in our absence, including obtaining the temperature of the animal in question.

By signing the fair registration form, the exhibitor certifies all animal projects will be drug free by Federal Food and Drug Administration standards. The exhibitor agrees to follow all withdrawal periods for animal health products and substances used, to practice good animal husbandry, and to ethically and humanely care for the project animal(s). The exhibitor acknowledges and accepts the fact that the project animal(s) may be subject to drug and residue testing. Upon a positive confirmation, forfeiture of all prize money, sale and/or market value, and trophies will be the penalty. The parents or guardians assume equal responsibility for following these and other prescribed guidelines set by the fair for these projects.

#### **EXHIBITORS RESPONSIBILITY FOR CARE AND FEEDING DURING FAIR**

**Red Flag Rule**: "All animals must be kept clean, fed, and have access to clean, fresh water throughout the day. The first time your pen(s) is/are not kept cleaned and/or there is/are no food or clean water the youth will receive a warning. They will have until the next check to remedy the situation – the expectation is that youth will be checking their projects every three hours (starting at 9 a.m., 12 Noon, 3 p.m., 6 p.m. and 9 p.m.). The second time the pen will be red flagged and the youth will not be eligible to exhibit that species in the following years at fair.

- 1. Only the superintendents of each species can red flag pens (for example the Sheep Superintendent can tag sheep pens). Warnings and red tags will be placed on pe10n cards.
- 2. Primary responsibility for grooming animals for show is that of the exhibitor. Parent/guardian and other exhibitors may assist.
- 3. Exhibitors are responsible for proper feeding and care of their animals, including keeping stalls, pens, and animals clean and neat at all times, until they are trucked out on Sunday, the last day of fair.
- 4. Final stall and pen clean-up, including washing swine pens, MUST be completed by 1:00 p.m. Sunday, the last day of fair.
- 5. Exhibitors will furnish their own feed and bedding.
- 6. All exhibitors MUST display pen cards with all information, readable by the public, above each animal exhibited. These pen cards are available on the fair website.

## **CLASSES and JUDGING**

- 1. All animals will be judged according to guidelines in the 4-H Handbooks. All judging is final.
- 2. Anyone not able to control his/her animal to the satisfaction of the judge will be excused from the show ring for the safety and in respect to other exhibitors.
- 3. Exhibitors MUST accompany their project animal in all classes to be judged and provide the judge with information about the project animal if asked. If you have more than one animal in the same class, then another exhibitor may assist you.
- 4. Classes may be combined or divided at the discretion of the Superintendents.
- 5. Showmanship classes must have at least three (3) exhibitors to hold a class.
- 6. Awards for all Showmanship Classes will be Ribbons up to 8th place. 1st place winner of each class a Trophy or Medallion and Rosette.
- 7. Club/Chapter Herd the herd must consist of at least three (3) animals, either market or breeding, and must be owned by three (3) different exhibitors. The class is to be judged after each species judging and entries must be made in the name of the local club.
- 8. HERDSMANSHIP: All livestock and small animal exhibitors are automatically entered into the Herdsmanship contest as a club. It is vital that the 4-H program put their best foot forward and demonstrates the care that we give to our animals and the hard work that we as a 4-H program put into our projects as well as how we work as a team. This is not an individual contest. Club Herdsmanship will be judged during the entire fair week and will be checked for the cleanliness of the animals and stalls, neatness of area outside their pen, attractiveness, and creativity of the Club's display area. The main cleaning of each species area should be done by 9:00 a.m. and all club signs must be easy to identify, readable, and have eye appeal. Each exhibitor's name card should be neatly displayed for each of their pens. Herdsmanship will be divided into Large Club (4 or more exhibits) and Small Club (3 or less exhibits). If the number of animals warrants splitting or combining the class, the Superintendents may do so after weigh-in.
- 9. Ribbons and/or Rosettes are to be awarded in all classes unless otherwise specified.
- 10. Champion and Reserve Champion awards will be given at the discretion of the judge and only if the number of exhibitors warrant such awards.

## **RECORD BOOKS**

Record Book Deadlines: Record books are required for all animals.

- 1. COMPLETED animal Record Books are required for each species to show at the Montcalm County Fair.
- 2. Late record books will not be accepted.
- 3. Record Books must be checked in accordance with the schedule above. If the Superintendent deems Record Book as incomplete, the Superintendent may refuse to accept the Record Book.
- 4. Record Books are available for each species separated by specific age levels at the MSU Montcalm Extension office and website at http://msue.anr.msu.edu/county/info/montcalm.
- 5. Make sure your club is clearly visible on your record book.

## **MARKET LIVESTOCK and SALE RULES**

- 1. The Livestock Auction will have a permanent sale order of: Poultry, Rabbits, Goats, Milk, Sheep, Beef, Swine. Sale order of Champions for each species will be Supreme Champion Market, Reserve Supreme Champion Market, Grand Champion Showman and Reserve Champion Showman.
- 2. Exhibitor's Age are 8 19 as of January 1st of the current fair year are eligible to sell through the Livestock Sale.
- 3. The Livestock Sale is open to 4-H and FFA members.
- 4. Ownership is required for all market animals. Exhibitors of Market Rabbits must have the sire or dam in their possession by April 1st of the current year.
- 5. All exhibitors with market livestock MUST participate in showmanship and complete a record book for that species.
- 6. All exhibitors with market livestock MUST complete YQCA (Youth for Quality Care of Animals) to sell at the fair. This certificate must be reported by the end of the registration period for online entries into Showorks or the exhibitor may not sell.
- 7. Livestock/Small Animal Committees may meet to review any situations or circumstances that may arise and re-evaluate the rules as they apply.
- 8. All livestock consignors will have a 4% commission of their gross sales deducted from their sale check to cover sales expenses. Dairy will also have a 4% sales commission deducted. 80% of the remaining proceeds will go to the exhibitor, and the Dairy Committee will retain 20% for funding scholarships and awards.
- 9. An individual animal may be registered as a "family floater" by more than one (1) immediate family member but can be shown by only one (1) family member.
- 10. Exhibitors may sell up to 2 Market projects. Following is a list of the eligible market projects: (A) One finished Market Steer or Heifer; (B) One or Two Market Hogs; (C) One or Two Market Sheep; (D) One or Two Market Goats; (E) Roaster pen of Market Chickens; (F) Fryer pen of Market Chickens; (G) Market pen of Turkeys; (H) Market Duck pen; (I) Market Geese pen; (J) Market pen of Rabbits; (K) Market Fryer Rabbit; This rule does not include the sale of Milk.

- 11. Grand Champion and Reserve Grand Champion MUST BE sold at the Livestock Sale, except if restricted by number of times through sale ring per exhibitor.
- 12. An exhibitor has one hour from the end of the species show to notify the auction committee that they would like to pull their animal from the auction.
- 13. All livestock checks will be issued once the sale expenses are paid and all revenues are received.

## CHECK - IN / WEIGH - IN

- 1. Dairy Exhibits: will be checked-in by superintendent or representative, must be in place by Monday of fair by 12:00 noon and any cows in milk will be allowed to leave the fairgrounds Friday of fair at noon.
- 2. Horse/Pony Exhibits: will be checked-in by superintendent or representative and may arrive Sunday of fair from 12 Noon to 4 p.m.
- 3. All Other Market Animal weigh-in and Breeding Stock check-in will be held on, Sunday of fair at the following times and locations:
  - All Beef, Goat, Sheep, Swine 6 a.m. to 12 p.m. Livestock Barn Scales
  - Market Rabbits 10 a.m. Small Animal Barn (Rabbit area)
  - Breeding Rabbits and Cavies 9 a.m. to 2 p.m. Small Animal Barn (Rabbit area)
  - Poultry 8 a.m. to 12 Noon Small Animal Barn (Poultry area)
- 4. All Market Animals MUST be weighed upon arrival.
- 5. All exhibitors must be present with their own animals at weigh-in.
- 6. There will be a health check of ALL animals before unloading. Check with the species Superintendent before unloading animal(s).
- 7. For any disputed weight, the animal must be re-weighed immediately. NOTE: there will be NO EXCEPTIONS to these rules.
- 8. Livestock shall remain in their stalls until officially released on Sunday after fair at 6:00 a.m.
- 9. Carcass Swine and Carcass Lambs will be trucked out Sunday of fair week following the live evaluation.
- 10. The buyer information forms and \$5.00 trucking fee per animal in the carcass hog and carcass lamb classes are due no later than 12 p.m. on Sunday of fair week to the weigh-in clerks.
- 11. Exhibitor must be present when the carcass animal is loaded.
- 12. It is the exhibitor's responsibility to make sure that the correct animal is sent to the processor.
- 13. Carcass exhibitor MUST ATTEND BOTH live evaluation and carcass class judging at processor unless prior arrangements are made with the sheep superintendent one week prior.

All animals must meet the following weight restrictions to sell and must be judged adequately finished by the Livestock Committee, Superintendent and Judges. Underweight and Overweight Swine WILL NOT be allowed to stay at Fair.

## **DEPARTMENT 7 – POULTRY**

- 1. All poultry (market and non-market) must be in the exhibitor's possession by May 1st of the current year.
- 2. Each poultry exhibitor must compete in showmanship with a bird that they have entered in a Breeding Poultry Class. Market poultry cannot be used in showmanship or breed classes.
- 3. All poultry (except waterfowl, pigeons, and doves), regardless of age, must meet the state requirements for Salmonella pullorum-typhoid testing. Poultry shall meet one or more of the following requirements.
  - A. Originate from a NPIP pullorum-typhoid clean flock and provide official documentation (a VS Form 9-2 or 9-3 that is issued within 90 days of fair). This form can generally be obtained from the source hatchery when chicks are ordered if requested. A copy of documentation will be maintained at the fairground during fair. OR
  - B. Have a negative official test for Salmonella pullorum-typhoid within 90 days before fair and remain segregated from all poultry of unknown status. A copy of documentation must be provided by the exhibitor and will be maintained at the fairground during fair. OR
  - C. Test negative at check in, prior to entering the poultry barn.
- 4. All birds MUST be brought in between 8 a.m. and 12 noon on Sunday for Pullorum testing and weigh-in, including those with a valid Pullorum certificate.
- 5. All poultry from the same farm requiring a Pullorum test must be checked in at the same time and must have all birds being shown present for testing, including market birds. There is a fee of \$1 per bird for testing and certification.
- 6. All poultry must be washed and clean, free of bugs, parasites, injury and illnesses. Poultry not meeting this guideline will be sent home.
- 7. All breed stock poultry must be at least three months of age or older by the day of the show, so that the birds are fully feathered which helps the judge evaluate them properly.
- 8. All poultry must have proper exhibit tag on cage printed on cardstock on Sunday before leaving poultry in barn. Printable exhibit tags are available online on the fair web site.
- 9. Please do not decorate your poultry cage until after show on Monday.
- 10. Each exhibitor may have five (5) exhibits in the breeding chicken and turkey division, four (4) exhibits in the waterfowl and pigeon division, two (2) exhibits in eggs and no more than two (2) exhibits in Market Poultry division.
- 11. Each exhibitor shall not exhibit more than two (2) exhibits per class.
- 12. Market Poultry birds must be from current year hatch.
- 13. All market poultry bands will be assigned at check in, after the bird is pullorum tested/verified, weight and health checked.
- 14. Please refer to the APA Standard of Perfection in order to enter your chicken in the right division. Chickens entered the wrong division will be judged in that division and will not place above birds entered in the correct division.

- 7. All non-standard breeds (formerly mixed breeds) must be shown in the non-standard breed class.
- 8. Refer to the American Rabbit Breeders' Association Standard of Perfection for breed, class, and show rule guidelines.
- 9. Class changes must be given on the Class Change Form to the Superintendent by 10 a.m. on Monday.
- 10. Each club must sign up for general barn duty with the superintendent at check-in
- 11. For show attire white long sleeves and dark pants are recommended, Lab Jackets and long dark skirt may be worn.
- 12. Exhibitors of Market Rabbit must have the sire or dam in their possession by April 1 of the current year.
- 13. Market Rabbits must weigh from 3.5 5.5 lbs. each and not be over 70 days old.
- 14. Market Rabbits will be weighed-in on Sunday at check-in and exhibitor must be present.
- 15. No market animals will be allowed to exhibit in breeding or fur classes.
- 16. Each Exhibitor may enter no more than 2 market rabbit exhibits.

# **DEPARTMENT 9 – HORSES/PONIES**

- 1. Horse Record Books are due between 6:00 p.m. and 8:00 p.m. on Wednesday, June 14th, to the horse entry show booth at the fairgrounds.
- 2. Horses/Ponies must be washed and clipped before coming to fair. Any horse or pony found not clean or clipped will be sent home upon inspection of the superintendents at check in. If sent home, it is the exhibitor's responsibility to have horse or pony back in the allotted time.
- 3. Check in will require exhibitors to unload their horse or pony in a designated area and be examined by a Superintendent. If horse/pony doesn't meet the health requirements of fair, it will be sent home.
- 4. Exhibitors must be present at check in of their horse or pony.
- 5. Stall fees are \$50 per horse and \$25 for tack.
- 6. The first Sunday of fair will be a required meeting for horse exhibitors (Or someone to represent them if they are showing another animal at the time.) at 6:00pm at the horse arena.
- 7. Classes with an (\*) are state 4-H Horse Show qualifying classes.
- 8. No stallions will be shown if foaled before January 1st of current year.
- 9. Only horses that wish to show in pony classes need to be measured on Sunday of fair by the Superintendent. Time and place will be posted at the announcer's booth. Ponies are 56 inches and under.
- 10. No class will be held for an exhibitor after the second call to the ring.
- 11. Special riders are allowed to have assistance in the show ring if necessary. Special riders are defined as children who experience a physical or mental impairment, which may require extra assistance or other consideration during riding activity.
- 12. Approved safety helmets required for all 5-8-year olds, and in English, saddleseat, bareback and speed classes. The Montcalm County Fair supports and encourages the use of approved safety helmets by every rider when mounted.
- 13. 8 -Year olds: may choose to participate as a Cloverbud on Monday evening or as a daily exhibitor all week. Choice of showing must be made by May 1st.
- 14. Long pants and boots required if mounted anywhere on the fairgrounds. Closed toed footwear is required for anyone involved with a horse related activity at the Fair.
- 15. Any exhibitor entering Walk/Trot classes may ONLY show in Walk/Trot events and costume class. Exhibitors entering Walk/Trot classes are not allowed to canter/lope on the grounds at any time during fair.
- 16. Classes with five (5) or less exhibitors may be combined except for Special Riders and Walk/Trot.
- 17. The Montcalm County 4-H Horse Leaders Executive Committee may split classes with more than ten (10) entries.
- 18. State delegate eligibility requires a submitted application on the back of the 4-H Horse/Pony Fair Registration form.
- 19. All Champion Trophies will be awarded on Saturday of Fair at the award ceremony time to be announced.
- 20. In Walk/Trot Gymkhana classes a 10 second penalty will be added for cantering.
- 21. Riders may only ride in one (1) jumping division.
- 22. In Western Events, Horsemanship is judged on the rider's performance and Pleasure is judged on the horse's performance. In English events, Equitation is judged on the rider's performance and Pleasure is judged on the horse's performance.
- 23. Riders may request special order to accommodate other fair commitments. Every attempt will be made to accommodate.
- 24. Riders swapping horses, as in primary to secondary, have a four-hour window of time to return a horse to the show fairgrounds. Once a horse leaves the fairgrounds it is finished showing for that day. Riders may only have ONE horse on the fairgrounds at a time. Each time a horse enters the fairgrounds, it must be inspected by a superintendent (even if the horse had previously been on the grounds).
- 25. Barn Curfew: 10 pm for exhibitors, 11 pm for leaders.
- 26. Only horse exhibitors are allowed to ride horses except for the Pro-am class.
- 27. Pen Cards are required to be posted on each stall.
- 28. No lunging of horses on any grass.
- 29. No cantering allowed outside of show rings.
- 30. If horse stalls are found unlocked during evening check by superintendents, the stall will be tagged. The exhibitor will be required to provide a community service prior to showing that day.

- 31. Call backs for Championship classes will go as follows, 1st-4th place Advanced, 1st place both intermediate and novice classes. Also the judge will have the authority to call back any others they would like.

# **Dress Code**

For all participants – No denim, no open toed shoes, no jewelry that will interfere with handling. No revealing clothing. No clothing with the club's name, personal identification, logos, or other printed words will be allowed. Long hair should be tied back. If at any time the judge feels your attire is not appropriate, it may reflect on your placement.

- 6. There is no limit to the number of years an individual can participate in the Sweepstakes contest or receive a trophy.
- 7. If an exhibitor qualifies for the Showmanship Sweepstakes in two (2) different species of animals, he/she must choose which animal he/she will represent. The Reserve Showman of the species not chosen will then be eligible for the Sweepstakes.
- 8. If two (2) contestants are tied for the Championship, there will be a runoff using two (2) species of animals chosen by the judges. Neither species will be the exhibitor's own animal.

# ASH FOUNDATION BUILDING STILL EXHIBITS GENERAL RULES

- 1. All youth exhibits must be judged between 10 am and 2 pm. on the Saturday of fair.
- 2. An exhibit tag must be present to be judged and securely attached to each exhibit.
- 3. The judging process is one-on-one interviews between a judge and exhibitor. NO ONE ELSE WILL BE ALLOWED IN THE JUDGING AREA! Project must represent youth's work and all exhibitors must be present during judging, except for a conflict where an exhibitor cannot be present. Exhibitor must complete a form from the MSU Montcalm Extension office, which would be presented to the Montcalm County Fairboard to approve a leader or parent to present the project. The still exhibit absentee request form must be submitted before June 1 to the MSU Montcalm Extension office for approval.
- 4. ALL EXHIBITS must be removed the Sunday following fair between 8 am. and 11 am
- 5. Exhibitor is limited to ONLY one (1) exhibit per class unless otherwise stated.
- 6. The judge will select A, B and C Award Ribbons. Honors, Outstanding and Trophy awards will be given from projects receiving A Awards.
- 7. When a class requires a poster, size of poster must be appropriate for project, unless specific size is listed.
- 8. Outstanding and Honors pictures will be taken on the Saturday of fair at the livestock arena after the Showmanship Sweepstakes.
- 9. Still Exhibit Auction:
  - A. An exhibitor may sell one time through the auction ring.
  - B. The item(s) must have been judged during still exhibit judging.
  - C. The auction will be held on the Sunday of Still Exhibit judging at 5 pm
  - D. All youth wanting to participate in the Montcalm County Fair Still Exhibit Auction must register ahead on the fair software and then confirm the day of Still Exhibit Judging between 10 am and 2 pm at the Information Table. If you do not confirm in the morning, you may still sell but will be at the end of auction and will not be included in the sale bill.
  - E. All food items sold at the auction must be duplicate of the project that has been judged. All food items must be whole or contain at least a full dozen items and must have a recipe card attached. All food items must have been properly stored.
  - F. If you are selling a still exhibit item, you may make a duplicate item to be sold and given to the buyer the night of the auction. If you choose not to make a duplicate item for the sale you will need to tell the superintendent of the department at the time of judging that you will be removing the item for the sale. The buyer will not be given the item after the sale (unless you made a duplicate item). The still exhibit item must be returned to your club exhibit and remain at the fair. It is your responsibility to get the item to the buyer at the end of fair. Exhibitors who do not deliver sold projects forfeit their sale proceeds.
  - G. The exhibitor must be present to sell their project.
  - H. A 10% commission will be deducted by the Montcalm County 4-H Council.

**NEW IN 2022** - Cottage Food Rules are in effect for the Still Exhibit Auction. You may have any item judged; however we cannot sell items that do not meet the Cottage Food Requirements. # What Food Products Meet the Requirements for Cottage Foods?

Select non-potentially hazardous foods (time and/or temperature controls not required to assure food safety - meaning foods can safely be kept at room temperature and do not require refrigeration) meet the requirements for cottage foods and can be prepared in a home kitchen and sold directly to consumers without a license. Many of these items are identified by MDARD. Examples include:

Breads, baked goods, Cookies, Cakes including celebration cakes (birthday, anniversary, wedding), Quick breads and muffins (e.g., pumpkin or zucchini bread, blueberry muffins) Cooked fruit pies, including pie crusts made

with butter, lard, or shortening, Fruit jams and jellies in glass jars that can be stored at room temperature (except vegetable and other non-fruit based jams/jellies), Confections and candies (made without alcohol), Granola, Dry herbs and dry herb mixtures, Dry baking mixes, Dry dip mixes, Dry soup mixes, Dehydrated vegetables or fruits, Popcorn, Cotton Candy, Chocolate covered pretzels, marshmallows, graham crackers, Rice Krispies treats, strawberries, pineapple, bananas, Coated or uncoated nuts, Dried pasta made with or without eggs, Roasted coffee beans or ground roasted coffee, Vinegar and flavored vinegars

# What Food Products Are NOT ALLOWED for Cottage Foods?

Potentially hazardous foods that require time and/or temperature control for safety are NOT ALLOWED to be produced in a home kitchen and must be produced in a licensed kitchen. Examples include: Meat and meat products like fresh and dried meats (jerky), Fish and fish products like smoked fish, Raw seed sprouts, Vegetable jams/jellies (e.g., hot pepper jelly), Canned fruits or vegetables like salsa or canned peaches, Canned fruit or vegetable butters like pumpkin or apple butter, Canned pickled products like corn relish, pickles, or sauerkraut, Pies or cakes that require refrigeration to assure safety like banana cream, pumpkin, lemon meringue or custard pies; cheesecake; and cakes with glaze or frosting that requires refrigeration (e.g., cream cheese frosting), Milk and dairy products like cheese or yogurt, Cut melons, Caramel apples, Hummus, Garlic in oil mixtures, All beverages, including fruit/vegetable juices, Kombucha tea, and apple cider, Ice and ice products, Cut tomatoes or chopped/shredded leafy greens, Confections that contain alcohol, like truffles or liqueur-filled chocolates, Focaccia style breads with fresh vegetables and/or cheeses, Food products made from fresh cut tomatoes, cut melons or cut leafy greens, Food products made with cooked vegetable products that are not canned, Sauces and condiments, including barbeque sauce, hot sauce, ketchup, or mustard, Salad dressings, Pet food or treats
